The bids will be opened in the presence of Bidders' representatives who choose to attend at 2022-04-07 (2078/12/24) 13:00 at the office of Marsyangdi Rural Municipality-8, Bhulbhule Lamjung Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amount as follows, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[05810129971088] at [Civil Bank Ltd., Bhulbhule, Lamjung] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
